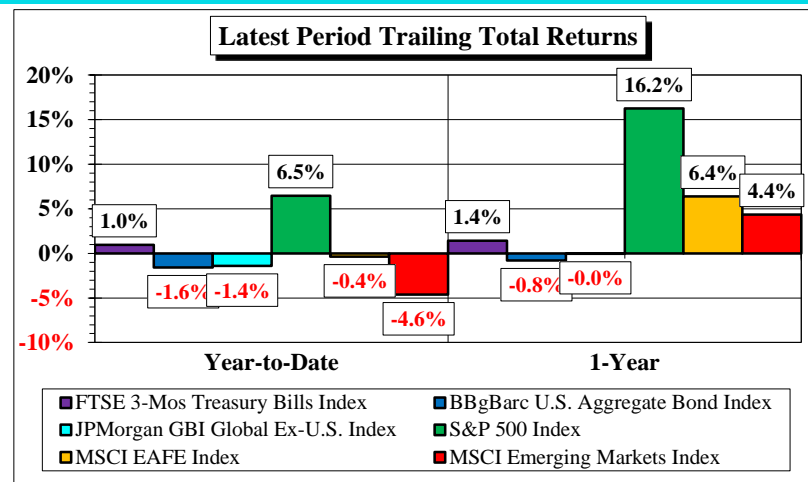

-20%/+25% - An initial investment of \$10,000 that falls to \$8,000 is a mathematical loss of **-20%**. To gain back your original \$10,000 investment from \$8,000 requires not a return of +20% but **+25%**. Given this mathematical principal prudent Investment Advisors hue to the edict of being the ‘tortoise’ rather than the ‘hare’. Or, in a different vernacular, provide Clients upside participation but with moreover downside protection.

R.F.A. Bond Market Fact

...except 2013, 1999, and 1994 – In the past 20 calendar years, the domestic bond market has never posted a negative total return...except 2013, 1999, and 1994. In a normal interest rate cycle, bonds can be the ‘buoyant life-jackets’ to a diversified asset allocation portfolio. Generally, bonds long-term total returns are not higher than stocks, but their fundamental structure and priority along the capital structure provide diversification benefits for investors. **2018 year-to-date the domestic bond market is down -1.6%.**
